Payment & Deadline (IMPORTANT)

To **secure your vendor space**, the vendor fee for the **first Food Court Friday you are approved to participate in** must be received **no later than April 1, 2026**.

Vendor spaces are **not guaranteed** until payment is received. Failure to submit payment by the deadline may result in forfeiture of your space.

Vendor Requirements

- Food vendors must provide a **Certificate of Liability Insurance** listing the City of Riverbank as **Additionally Insured**.
- Food vendors must submit a valid **Stanislaus County Temporary Food Facility Permit**.
- Electricity is **not available**. Vendors requiring power must provide their own **quiet generator**.
- Vendors must provide their own **canopy (properly secured), tables, chairs, lighting, and all necessary equipment**.
